24/37 Public Questions

A member of the public reminded the meeting of the Lanlivery D-Day arrangements on 6th June as follows:-

- 9.15pm beacon in Crown grounds, tribute to the fallen by a village veteran.

A member of the public reported that diggers and bulldozers had been creating access entrances off the highway at Crift Farm and it also appeared that more building work/removal of walls was taking place. Cllr Sinkins suggested that a visual record be kept in the event that enforcement proved to be appropriate.

24/46 Playing Field

It was proposed by Cllr Challis, seconded Paterson and RESOLVED that the amended quote from Kompan to include wet pour surfacing, rather than matting, should be accepted as although there would be an additional cost the result should be more durable and safer. It was noted that the fund raising group would continue to fundraise for the next stage of the project; they would be invited to report back on progress to the next meeting.

24/47 To Receive Reports from Councillors

Cllr Sinkins noted that potholes were no longer being filled promptly after being reported. Members considered that, although unacceptable, this was probably down to CC budgetary constraints.

Cllr Paterson reported that roadside hedges were getting quite overgrown and restricting visibility. It was noted that hedges are not usually cut back until July/August to safeguard nesting birds but that short areas where overgrown hedges restrict vision i.e. on corners can be trimmed back as appropriate

Cllr Wright reported that the triangle was looking very overgrown. The Parish Clerk reported that she had instructed Chris Lewsey to tidy it twice annually and he had undertaken to do so but he had not been on site to date. A member of the public present agreed to follow up as he was in contact with Chris.

Cllr Paterson noted that traffic management at Redmoor School appeared to be improving slightly, although it was still very problematic. He understood that a member of staff was now monitoring the situation.
